REGULAR, INDIVIDUAL: _____ \$20.00

A person applying for a regular, (full), membership should plan on participating in the club's activities and attending the club's meetings on a regular basis. As a regular member, you are eligible to vote and hold office. If you live 100+ miles from Denver, regular membership is not available, but associate membership is.

REGULAR, JOINT: _____ \$25.00

This is for 2 persons per household, both having regular, (full), membership status. (Read description above.)

ASSOCIATE: _____ \$15.00

If you live 100+ miles from Denver, you are not eligible for full membership, but associate membership is available. If you are not planning on regularly participating in the club's activities or holding a club office, you may want to apply for an associate membership. **THIS CAN BE A JOINT OR HOUSEHOLD MEMBERSHIP.**

All memberships include a subscription to the club newsletter, **Beardie Works**.

Please submit your check, payable to the Rocky Mountain Bearded Collie Connection or RMBCC with your completed membership application. Your check will be cashed and the membership fee held in account until the voting procedure is completed, at which time the fee will be processed accordingly.

NOTE: The club's fiscal year runs from June 1 to the next year's May 31st, (at which time dues are payable). Membership applications approved during the last 3 months of the fiscal year will be granted provisional membership status until the beginning of the fiscal year, at which time they may be granted regular membership status.
